IED – Istituto Europeo di Design, at its Madrid campus, are launching a new call for applications for its Scholarships aimed at Undergraduate, Diploma, and Vocational Training programs. The goal is to offer an opportunity to young people who demonstrate strong motivation to pursue studies at IED Madrid.

**Five Scholarships will be awarded, each covering 25% of the Course Fee** (not applicable to the reservation fee or enrollment fee).

An ad hoc expert jury will assess candidates based on motivation, capability, and overall presentation.

Scholarship may remain unawarded if the jury considers that the submitted applications do not meet the minimum quality standards.

Candidates may apply for a Scholarship in the following programs:

## TERMS AND CONDITIONS

### 1. Participants.

Applications are open to individuals who will be 18 years old before December 31 of the year the course begins. Participants must hold a high school diploma or be completing their high school studies or equivalent during the 2024/25 academic year and wish to enter the first year of one of the eligible IED Madrid programs..

Each candidate may apply for only one Scholarship for a single course. Applying to more than one will result in disqualification.

### 2. How to Apply

To participate in the Scholarships Contest, candidates must send the following documents to the email: **admission.madrid@ied.es**:

- Copy of ID card or passport
- Motivation letter in the language of the chosen course
- A link to a presentation video (maximum one minute), where the candidate introduces themselves and explains, in the language of the chosen course, their motivation to study design at IED Madrid, and why they deserve a Scholarship. The video must be uploaded to a cloud or digital repository.

The videos submitted must be original and unpublished and created specifically for the participation in the Scholarship for the Undergraduate, Diploma and Vocational Training programs at IED Madrid.

### 3. Submission

All application materials must be sent in a single email to: **admission.madrid@ied.es**

### 4. Application Deadline and Scholarship Allocation

Scholarships will be awarded on a rolling basis as applications are received. Each submission will be reviewed upon arrival and, if it meets the requirements, a decision will be communicated within 48 business hours. A maximum of five (5) Scholarships will be awarded. Once all five have been assigned, the application process will be closed—even if that occurs before the official deadline of July 15, 2025 (11:59 p.m.)

5. The award is personal and non-transferable, and the student who has been awarded a Scholarship must take the course for which he/she is eligible.
6. The Scholarship is non-refundable, non-exchangeable for cash, and cannot be transferred to other courses or calls for applications. It cannot be combined with other IED Madrid promotions. .
7. In order to receive the scholarship it is essential to accept the scholarship within 3 calendar days from the date of notification of the award and pay the Enrollment Fee within 5 additional calendar days upon acceptance.

### 8. Conditions

The candidate must accept the general academic regulations of IED Madrid and sign the specific regulations related to the Scholarship within two weeks of receiving the Scholarship notification.

9. The candidate will have to study the entire course at IED Madrid, losing the scholarship if the winner transfers to another location.

10. Winners are required to participate actively in all special and interdisciplinary projects promoted by the school: presentation events, mentored contests, and workshops.
11. If the course is not delivered due to insufficient enrollment, the Scholarship will be forfeited.
12. If the candidate decides not to enroll in the September 2025 intake, both the Scholarship and the Enrollment Fee will be lost.
13. Failure to comply with any of these obligations will result in the loss of the Scholarship.
14. Winners authorize IED to publish their full name in newsletters and other promotional materials.
15. Participation in this contest implies full acceptance of these terms and conditions.
- 16. Renewal Requirements.** The Scholarship may be renewed in subsequent academic years if the student maintains the academic excellence and attendance standards defined by IED Madrid. These include, among others: a minimum 85% attendance rate and an average grade of 7.5 over 10 each year.
17. Scholarship winners will be contacted by the IED Madrid Admission Department.

## HOW TO PARTICIPATE

**Step 1.** Read the terms and conditions carefully.

**Step 2.** Choose a single program to apply for.

**Step 3.** Submit the following documents via email:

- Copy of ID card or passport
- Motivation letter in the language of the chosen course
- Link to a one-minute presentation video

**Step 4.** If you win a Scholarship, you will have 3 days to confirm your acceptance and 5 days to complete your enrollment at IED Madrid.
